Line 01: SECTION 1. The Department of Treasury shall increase the issuance of Line 02: treasury bonds over the next 3 fiscal years.

Line 01: SECTION 1. The purpose of this bill is to reform the Supreme Court's code of

Line 02: conduct by creating accountability for any judge that fails to comply.

Line 03: SECTION 2. The current code is designed to provide ethics rules and principles

Line 04: that guide the conduct of the members of the Court. However, the Code contains

Line 01: SECTION 1. Make the regulations regarding Tobacco & Nicotine products Line 02: stronger to prevent people under legal age in Virginia from gaining access to Line 03: them. Additionally, the legal age to purchase and buy tobacco & nicotine Line 04: products will be increased.

A Bill to Impose a Regulated Ethics Code onto the Supreme Court

Be it enacted,

Line 00: ARTICLE 1: The Supreme Court of the United States shall be subjected to a code of ethics regulated by a commission comprising both Congress and the Department of Justice. Such a code of conduct shall include but not be limited to the following:

Line 01: Strict limits on gifts with monetary value

Line 02: Required recusals on cases concerning close familial relations, former or current business associates, or the presidents responsible for their appointment.

Line 03: Violations shall result in a maximum punishment of recommendation for impeachment by said committee, and the committee shall have the power to force recusal in cases of close relation.

Line 04: ARTICLE 2: "Presidents responsible for appointment" is defined as both to the Supreme Court or any previous circuit court appointments. "Recusal" is defined as abstaining from judgment in a case.

Line 05: ARTICLE 3: The House Ethics Committee in collaboration with the Justice Department will oversee the enforcement of this bill.

Line 06: ARTICLE 4: This bill will take effect January 1, 2025.
