# A BILL TO ANNEX THE REPUBLIC OF KOREA FOR THE PRESERVATION OF LIBERTY AND SECURITY

Be it enacted,

Line 01: ARTICLE I: The United States shall annex the Republic of Korea (South Korea) as

Line 02: a U.S. territory to promote democracy and counter the threats posed by the

Line 03: People's Republic of China and the Democratic People's Republic of Korea

Line 04: (North Korea).

Line 06: ARTICLE II: Annexation shall be defined as the full integration of South Korea as a

Line 07: U.S. territory, granting its citizens U.S. territorial rights while maintaining

Line 08: regional military and economic stability. This action will deter aggression from

Line 09: adversarial nations and ensure the continued expansion of democratic ideals in

Line 10: East Asia.

Line 12: ARTICLE III: In light of the United States' recent unsuccessful attempt to purchase

Line 13: Greenland from Denmark, this annexation provides a strategic alternative. South

Line 14: Korea offers a highly developed economy, advanced technological infrastructure,

Line 15: and a strong military alliance with the United States, making it an enticing

Line 16: second option. This move will strengthen U.S. global influence and provide

Line 17: another crucial foothold in the Pacific region.

A Bill to Establish Ranked-Choice Voting in the Commonwealth of Virginia

Be it enacted,

Line 01: Be it ENACTED by the Student Congress here Assembled that:

Line 02:

Line 03: SECTION 1. The Constitution of the Commonwealth of Virginia shall be amended

Line 04: to allow for the election of the members of the Virginia Senate and Virginia House

Line 05: of Delegates using ranked-choice voting.

Line 06:

Line 07: SECTION 2. The Constitution of the Commonwealth of Virginia shall also be

Line 08: amended to allow for the election of the governor, lieutenant governor, and

Line 09: attorney general of Virginia using ranked-choice voting.

Line 11: SECTION 3. Members of the United States Senate and United States House of

Line 12: Representatives shall be elected using ranked-choice voting.

Line 14: SECTION 4. In the context of the bill, ranked-choice voting means the method of

Line 15: casting and tabulating votes in which electors rank candidates in order of

Line 16: preference, tabulation proceeds in sequential rounds in which last place

Line 17: candidates are defeated and the candidate with the most votes in the final round is

Line 18: elected.

Line 20: SECTION 5. All laws dealing with procedures regarding the transmission and

Line 21: counting of votes currently established shall remain in place.

Line 23: SECTION 6. This law shall take effect upon the passage of a constitutional

Line 24: amendment with the details of this legislation. All laws in conflict with this

Line 25: legislation are hereby declared null and void.
