WHEREAS, Greenland's strategic location and resources are a matter of interest for the United States, yet Greenland cannot create its own international agreements for defense or trade;

WHEREAS, Greenland and Denmarks' capitals are over 2,000 miles apart, and recent polls show that a supermajority of Greenlanders support independence from the Danish;

THEREFORE Be it resolved by the Student Congress here assembled that the United States of America shall support Greenland's right to sovereignty from the Kingdom of Denmark or any other foreign players.

The Department of Justice shall oversee the implementation of this legislation.
