A Bill to Provide Relief and Support for Students Affected by Natural Disasters

Be it enacted,

Line 01: Section 1. The U.S will establish a nationwide natural disaster response Line 02: network for schools. It will create systems that allow schools to respond to and assist Line 03: communities affected by natural disasters. The bill outlines provisions for a disaster Line 04: relief fund, mandates emergency preparedness education, establishes a simulated Line 05: disaster response program, and creates a student volunteer network to help in disaster Line 06: relief efforts. All schools will be required to incorporate emergency preparedness Line 07: education into their curricula. This will include training students and staff on how to Line 08: respond to natural disasters such as hurricanes, earthquakes, floods, and wildfires. The Line 09: curriculum will cover the basics of first aid, evacuation procedures, and effective Line 10: communication in the event of a disaster. Each school will enact an annual Line 11: disaster simulation drills, which will be aligned with other emergency preparedness Line 12: drills such as fire drills. These simulations will be coordinated to reflect various types of Line 13: natural disasters (e.g., earthquakes, and hurricanes) and will ensure that students and Line 14: staff are well-practiced in disaster response. The simulations will involve local Line 15: emergency responders and will be designed to test the school's readiness and the Line 16: effectiveness of its emergency response plan. As well as program will be created to Line 17: allow students to become trained volunteers for disaster relief. This bill will establish a Line 18: disaster relief fund that helps students directly impacted by natural disasters.

A Bill to Legalize Euthanasia for Terminally III Patients to Provide a Humane End-of-Life Option for Individuals Suffering from Incurable Diseases

Be it enacted,

Line 01: SECTION 1. The practice of euthanasia shall be legalized for terminally ill patients

Line 02: in the United States who are suffering from an incurable disease and have been

Line 03: medically evaluated to be in the final stages of life. Euthanasia will be allowed only

Line 04: with the explicit, informed consent of the patient and under the supervision of

Line 05: qualified medical professionals.

Line 06: SECTION 2. For the purposes of this legislation, "terminally ill" refers to individuals

Line 07: diagnosed with a medical condition that is expected to result in death within six

Line 08: months, as determined by a licensed physician. "Euthanasia" refers to the act of

Line 09: intentionally ending a life to relieve suffering, administered by a licensed medical

Line 10: practitioner under strict legal and ethical guidelines.

Line 11: SECTION 3. The Department of Health and Human Services (HHS) shall oversee

Line 12: the enforcement of this legislation. The HHS will establish regulatory guidelines for

Line 13: the procedure, ensure compliance through regular audits, and hold accountable any

Line 14: medical professionals who fail to adhere to the law's requirements.

Line 15: This will include a reporting system where medical practitioners are required to

BE IT FNACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

Section 1. FEMA will be required by law to supply an adequate amount of aid to areas of any income and expedite the approval and distribution of funding for these key areas. FEMA will form an oversight committee to make sure that bias is kept to a minimum. This aid will include working directly with local governments to quickly and efficiently distribute aid, prepare supplies for disasters, and encourage and fund the implementation of disaster-resilient infrastructure. Failure to supply enough aid will lead to areas of risk that will be identified beforehand through technology that can predict where disasters could occur.

Section 2. The technology used to predict disasters is called Hazus, and it is a GIS-based desktop software with a collection of inventory databases for every U.S. state and territory. Hazus identifies areas with high risk for natural hazards and estimates the physical, economic, and social impacts of earthquakes, hurricanes, floods, and tsunamis.

Section 3. The government body responsible for overseeing this bill will be the Federal Emergency Management Agency (FEMA), which handles disasters across the US.

Section 4. This bill will be enacted as soon as possible, given the nature of the issue.

Section 5. All laws in conflict with this legislation are hereby declared null and void.

Be it enacted,

Line 01: SECTION 1. A carbon tax starting at \$0.045 per kilowatt-hour (kWh) of electricity

Line 02: consumed shall be enacted on all United States based cryptocurrency companies to

Line 03: incentivize them to switch to renewable sources of energy and adopt alternative

Line 04: mining practices that are less energy-intensive.
