Docket A: International Resolution I-0614

Acquisition of Greenland for America

Be it resolved,

Article 1: Let it be known, that Greenland is an immense landmass with very important strategic and economic value to the United States of America.

Article 2: Let it be stated, that the United States recognizes the ownership of Greenland under Denmark and has two propositions to resolve this issue diplomatically.

Article 3: Let it be issued that the two propositions will be either a joint occupation of Greenland by the United States and Denmark, with NATO as a 3rd party observer to assure equal representation of both countries, or Denmark shall accept \$50 billion dollars with exclusive trade rights that will include priority for Denmark's most priced goods, medical supplies.

Article 4: Let it be resolved that the acquisition of Greenland is necessary in order to bolster NATO presence in the arctic region and allow for a more efficient mobilization of American troops in case of retaliation from Russia or its allies.

Article 5: Let it be defined that a new article will be created for NATO that will allow only the founding members the ability to monitor the actions of both Denmark and America within Greenland.

Article 6: This legislation shall be passed through the United States Congress as well as Denmark's Parliament before being implemented by the founding NATO members.

Article 7: This legislation shall be enforced on June 14th, 2025.

Article 8: Any legislation in conflict with this bill shall be declared null and void.

A Bill for the expansion of restorative justice in Virginia

Be it resolved,

WHEREAS the mean cost of incarceration for any single inmate in the commonwealth of Virginia is \$145.18 per day as estimated in 2023, placing significant extraneous strains on the taxpayer; and

WHEREAS it is to the benefit of Virginian communities to reduce recidivism through correctional service and education; and

WHEREAS it is under the discretion of the Virginia Judicial system and the due diligence of Virginia's elected state officials to extend restorative justice programs into critical areas; therefore be it

RESOLVED, by the Student Congress here assembled, to expand restorative justice programs within Virginia, insofar as it does not marginally increase the commonwealth's tax expenses, beginning in 2026 at the beginning of the new budget cycle.
