A Bill to Ban the Trade of Cryptocurrency among Members of Congress and Their Families

Line 01: encourage South Korea, China, and North Korea to comply with the

Line 02: conditions outlined in Section II of this legislation. If, during

Line 03: 2028, 80% of the conditions are met, including at least condition 3b,

Line 04: the United States will proceed to reduce American troops in South

Line 05: Korea by 2,800 (10%), reduce American tariffs on Chinese consumer

Line 06: electronics back down to 10%, and return 10% of land in US military

Line 07: bases in South Korea to the host country. If, by the specified date, Line 08:

Line 09: 80% of the conditions are not met, including at least condition 3b,

Line 10: America will halt and reverse its progress towards the defined

## **Docket B: International Bill 5581**

A Bill to Regulate Mining Operations in Greenland to Protect the Environment

Be it enacted,

Line 01: SECTION 1. By 2026, the government of Greenland will implement stricter regulations on mining operations to ensure that mining activities do not harm the environment. The regulations will particularly focus on protecting water sources, wildlife habitats, and local communities.

Line 02: SECTION 2. "Mining Operations" refers to the extraction of minerals, metals, and other natural resources from the earth.

"Environmental Protection" refers to the measures taken to prevent pollution, habitat destruction, and negative impacts on ecosystems during mining activities.

Line 03: SECTION 3. The Ministry of Natural Resources and Environment will oversee the enforcement of these regulations. Specific enforcement mechanisms include:
