LINE 01: Section 1. Individuals currently serving a prison sentence with a

LINE 02: duration of 15 years or less for nonviolent offences and have not been

LINE 03: convicted of a violent offense shall have the remaining duration of

LINE 04: their sentence commuted to house arrest.
