A bill to Establish a Restorative Justice Program for Non-Violent Offenders

Be it enacted,

Section 1: Establishes a restorative justice framework with the goal of rehabilitating non-violent criminals.

Section 2: Restorative Justice is a process that facilitates dialogue between victims, offenders, and the community to repair harm. Non-violent crimes are defined as crimes in which an offender or perpetrator does not use or threatens to use harmful force upon a victim.

Section 3: The Virginia Judicial System will oversee the implementation of this legislation.

Section 4: This act will take effect one year after passing.

Section 5: all laws in conflict shall be declared null and void.

Section 3. The National Intellectual Property Rights Coordination Center would oversee the implementation of this bill.
