Section Two: FDA is the The Food and Drug Administration. A patent is a government authority or license conferring a right or title for a set period, especially the sole right to exclude others from making, using, or selling an invention. A monopoly is when a company has complete control over its target market.

Section Three: The Food and Drug Administration will oversee the implementation of this legislation.

Section Four: This bill will go into effect May 20, 2024.

Section Five: All laws in conflict with this legislation are hereby declared null and void.
