Line 01: SECTION 1. This bill would align the state of Virginia with the majority of the Line 02: country Line restoring the right to felons after they have served their time in prison Line 03: and finished any parole or probation. Additionally, this bill would change the state Line 04: policy of Governor approval being the exclusive means of ex-felon voting Line 05: restoration. Including a group separated from general society for years gives them Line 06: an opportunity to be involved in their present communities, transitioning them back Line 07: into society. A Bill to Reform the Pharmaceutical Patent System to Aid the Drug Pricing Crisis

Be it enacted,

Line 01: A pharmaceutical company will be allowed to assert no more than one Line 02: patent per patent thicket in litigation.

Line 03: A company "asserts" a patent when it proclaims that their patent has Line 04: been infringed upon. They may then enter litigation when they involve Line 05: the legal system to enforce the protection of their patent.

Line 06: A "patent thicket" is a collection of overlapping patents on a single Line 07: pharmaceutical invention, with each patent covering a slightly Line 08: different part of the invention's design. Their purpose is to prevent Line 09: competition, increasing drug prices.

Line 10: This legislation will be overseen by the United States Patent and Line 11: Trademark Office under the Department of Commerce.

Line 12: This legislation will take effect on January 1, 2025. All laws in Line 13: conflict with this legislation are hereby declared null and void.

Line 01: SECTION 1. This Act may be cited as the "Tax Reform and Economic Growth Act."

Line 02: SECTION 2. The corporate income tax rate shall be adjusted from its current rate Line 03: of 21% to 25%.

Line 04: SECTION 3. Personal income tax brackets shall be simplified and adjusted to Ling 05: ensure fair and progressive taxation. A Bill to Fund Training of Terrestrial Birds as Companion Animals

Be it enacted,

Line 01: Section 1. This Act may be cited as the "Feathered Friends Fund."

Line02: Section 2. Overview The purpose of this Act is to allocate funds for the Line 03: training and development of a team of terrestrial birds to serve as companion Line 04: animals.

Line 05: Section 3. Definitions Terrestrial birds refer to bird species that primarily inhabit Line 06: land or ground habitats, as opposed to spending a significant amount of time in the Line 07: air or water. These birds are adapted to life on land and typically have features such Line 08: as strong legs for walking or running, rather than specialized adaptations for flight Line 09: or swimming. Examples of terrestrial birds include ostriches, emus, turkeys, Line 10: chickens, pheasants, quails, and some species of ducks and geese. These birds Line 11: often forage for food on the ground and build nests on land rather than in trees.

Line 12: Section 4. Allocation of Funds An amount of 250 million dollars shall be Line 13: appropriated from the federal budget for the implementation of this initiative.

Line 14: Section 5. Research and Development A portion of the allocated funds shall be Line 15: earmarked for research and development initiatives aimed at enhancing the Line 16: effectiveness of the training program and improving the overall welfare of Line 17: companion birds.

Line 18: Section 6. All laws in conflict with this legislation are hereby declared null and Line 19: void.

#### A BILL TO APPROPRIATE THE RIGHT TO REPAIR FOR ALL AMERICAN CITIZENS

Be it enacted,

Line 01: SECTION 1. The enactment of this bill will prevent consumer electronics and Line 02: appliance businesses from denying independent repair shops access to specialized Line 03: equipment, parts, and service manuals to complete a repair. They must also provide Line 04: these businesses with fair access. All service manuals or information required to Line 05: repair a consumer electronic/appliance will be provided at no cost in a non-physical Line 06: format.

Line 07: SECTION 2. A. Fair access will be defined as providing these parts, tools, and Line 08: information by the manufacturer at the same cost they already charge their Line 09: authorized repair networks.

Line 10: B. Consumer electronics and appliances will be defined as phones, televisions,

Line 11: tablets, computers, washing machines, microwaves, fridges, dishwashers,

Line 12: dryers, and freezers.

Line 13: C. Independent repair shops will be defined as shops not currently designated by Line 14: the manufacturer as "authorized" repair providers.

Line 15: D. The bill excludes manufacturers who currently do not produce repair items or

Line 16: support the repair of their products. This bill will also exclude alarm systems,

Line 17: video game consoles, specialty equipment not sold to consumers, equipment Line 18: and medical devices.
