Be it enacted,

BILL: Sleep Mode Law (V)

Section 1:

This bill aims to promote healthier sleep habits among minors by requiring social media platforms to automatically disable accounts for users under the age of 16 between 10:00 PM and 6:00 AM.

Section 2:

All social media platforms operating in the United States must implement technology that enforces Sleep Mode by restricting access for users under 16 during the designated hours. The system must be capable of accurately verifying users' ages to ensure compliance.

Section 3:

- (a) This bill seeks to protect the well-being of minors by reducing nighttime screen exposure and promoting better sleep habits.
- (b) A Compliance Oversight Board, consisting of experts in child development, technology, and digital safety, will monitor the implementation of this requirement and assess its impact. The Board will submit annual reports to Congress.
- (c) Parents or legal guardians may request an override to allow access during restricted hours if they believe their child has a legitimate reason to be online. The override request must be submitted through a secure platform provided by the social media company and renewed monthly.

Section 4:

This bill will take effect on January 1, 2026, requiring social media companies to update their platforms and policies accordingly.

BE IT ENACTED BY THIS STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1. SECTION I. Article III in the constitution shall hereby be amended to
- 2. implement term limits of 18 years on supreme court justices.
- 3. SECTION II. Term limits will be defined as a set time in which a supreme court
- 4. justice may serve, which shall henceforth be known as 18 years.
- 5. Every two years, a supreme court justice will step down from their
- 6. position, and a new one shall take their place. The new justice shall
- 7. be chosen by the current president, so that each president will
- 8. choose at least two justices during their presidential term.
- 9. SECTION III. The Department of Justice shall oversee the passage of this
- 10. legislation
- 11. SECTION IV. This bill shall be implemented immediately upon passage, so that
- 12. the supreme court justice with the longest term shall step down
- 13. first, then two years later the justice with the next longest term
- 14. shall step down, and so on, until the new term limits are fully
- 15. implemented.

SECTION 1. The United States of America shall retract its membership from the Antarctic Treaty and shall exercise its right to claim Antarctica.

- SECTION 2. A. The United States of America shall retract its status as a member of the Antarctic Treaty and the Protocol on Environmental Protection to the Antarctic Treaty, however, shall remain in other treaties of the Antarctic Treaty System.
- B. The United States of America shall exercise its right to claim Antarctica by forming a new unincorporated and unorganized United States territory encompassing the entirety of Marie Byrd Land.
- SECTION 3. Implementation of this bill shall be carried out by the President of the United States and the Department of State, with Congress issuing additional legislation if necessary.
- SECTION 4. This legislation shall take effect on December 1, 2025. All laws in conflict with this legislation are hereby declared null and void.

A standard, binding Code of Conduct shall be established and enforced upon Justices of the Supreme Court of the United States to ensure ethical consistency, transparency, and accountability within the court.

A. "Justices of the Supreme Court of the United States" shall be defined as the nine active Justices serving on the Court at any given time.

The Supreme Court of the United States shall be tasked with drafting, and following the Code of Conduct.

A. An oversight committee composed of retired federal judges, legal ethics experts, and public representatives shall be established within the Judicial Conference of the United States to ratify the Code of Conduct as well as monitor compliance and investigate complaints.

B. Justices found in violation of the Code shall be subject to formal review by the United States Senate who will then vote to request Articles of Impeachment from the House of Representatives based on the severity of the violation.

SECTION 4.

This legislation will take effect on March 4, 2026. All laws in conflict with this legislation are hereby declared null and void.
