The Combined Local Emissions and Automotive Review Act (CLEAR) Act

Be it enacted,

Line 01: Article 1: This bill will unify the annual safety inspection and biennial emission Line 02: inspection into one mandatory inspection. This unified inspection shall be required Line 03: annually for all vehicles registered in the Commonwealth. No regulation changes Line 04: for either procedure will take place, considering this legislation only seeks to unify.

Line 05: Article 2: The emissions inspection shall be defined as the procedure that measures Line 06: the pollutants emitted by a vehicle's exhaust system to ensure compliance with Line 07: environmental standards, as overseen by the Department of Environmental Quality.

Line 08: Article 3: The Virginia Department of State Police and the Department of Line 09: Environmental Quality shall jointly certify and regulate all vehicle inspection Line 10: stations authorized to conduct unified inspections. All stations in emissions-required Line 11: areas shall be equipped to perform both inspections in a single visit. The Virginia Line 12: Department of Motor Vehicles will also maintain digital records of compliance Line 13: accessible to law enforcement in real-time.

Line 14: Article 4: This legislation shall be passed by January 1st. 2027 and will take effect Line 15: upon the vehicle owner's next scheduled vehicle inspection. This will allocate Line 16: enough time for places of inspection to assimilate themselves with the double Line 17: inspections.

Line 18: Article 5: All laws opposing this legislation are hereby declared null and void.

STABLE (Systemic Transparency And Bankruptcy Liquidation Efficiency) Act

Be it enacted,

Line 01: ARTICLE 1: The U.S. shall promote the filing of Chapter 11 bankruptcy

Line 02: by (a) requiring that all business entities under U.S. jurisdiction create

Line 03: and maintain a "living will," and (b) allowing the FDIC to file involuntary

Line 04: bankruptcy petitions against business entities if that entity is proven

Line 05: insolvent by the "balance sheet insolvency" test.

A Bill to Mandate a Revenue Sharing Model to Ensure Children Featured in Family Youtube Channels Receive Fair Compensation

Be it enacted,

SECTION 1. All family YouTube channels operating in the Commonwealth of Virginia must allocate a minimum of 50% of income earned from monetized content to any minor who appears in more than 30% of said content.

SECTION 2. A. Family YouTube channel refers to any monetized video channel or account operated by a parent or guardian featuring their minor children.

B. Monetized content includes videos generating revenue through any form of online income.

C. Minor refers to any child under the age of 18.

SECTION 3. The Virginia Department of Labor and Industry shall be responsible for enforcing this legislation.

A. Channels must submit a quarterly documentation of video content and income breakdown.

B. Any failure to comply will result in civil penalties, including fines of up to \$10,000.

SECTION 4. This legislation will take effect on July 1st, 2025. All laws in conflict with this legislation are hereby declared null and void.

Maple Trade Fairness Act (MTF)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Article 1. As Canada is a valuable resource to The United States' trade, we shall reduce all tariff percentages against Canada to zero percent from its current rate, to reduce prices on imports to The United States.

The Protected Consumer Health Information Act (P.C.H.I.A)

Be it enacted,

The Protected Consumer Health Information Act (P.C.H.I.A)

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

Article 1: Companies that specialize in direct-to-consumer collection or usage of protected consumer health information shall be mandated to follow federally regulated policies and procedures for liquidating or selling of protected consumer health information in regard to filing for bankruptcy. This shall ensure uniform policy for consumer protection of personal identifiable information and protected consumer health information to address oversights in current legislation. The PCHIA Act will require that personal identifiable information shall be considered a protected asset during the bankruptcy process.

Article 2: Protected consumer health information shall be defined as any medical information pertaining to past, present, or future physical or mental health or condition of an individual including personal identifiable information; the past, present, or future payments regarding healthcare treatment of an individual; provision of healthcare to an individual. Personal identifiable information (PII) shall be defined as any information connected to an individual that can be used to expose an individual's identity, such as, name, address, phone number, social security, familial connections, etc. Protected assets shall be defined as any property considered valued within the bankruptcy process, and implicated in the PCHIA Act shall not be automatically subject to existing legislation regarding the liquidation of assets.

Article 3: This legislation shall be enforced by the United States Bankruptcy Courts.

Article 4: This legislation shall be enacted upon January 1, 2026

Article 5: All laws in conflict with this legislation are hereby declared null and void.
