Line 14: or eliminate congressionally established agencies such as the Consumer Financial

Line 15: Protection Bureau (CFPB);

Line 17: or significantly reduce the function of agencies without Congressional authorization

Line 18: shall be considered a violation of the separation of powers doctrine and the

# **Docket A: Domestic Bill 5383**

A Bill to limit the Regulations of Opioids

Be it enacted,

Line 1: ARTICLE I: The United Sates shall legalize the purchase and consumption Line 2: of all drugs derived from the Papaver somniferum (Opium Poopy) without Line 3: the requirement of a licensed physician's prescription to consumers over Line 4: the age of 21.

Line 5: ARTICLE II: The United Sates shall legalize the prescription and Line 6: consumption of all drugs derived from the Papaver somniferum (Opium Line 7: Poppy) to patients under the age of 21 by state licensed physicians.

Line 8: ARTICLE III: The Department of Commerce in coordination with the Line 9: Food and Drug Administration and the department of Health and Human Line 10: Services will implement this bill.

Line 11: ARTICLE IV: All drugs derived from the Papaver somniferum (Opium Line 12: Poppy) will undergo certification by the Food and Drug Administration in Line 13: order to be sold in markets within the United Sates of America and all Line 14: territories under its jurisdiction.

Line 15: ARTICLE V: In order for a business to sell a drug derived from the Line 16: Papaver somniferum (Opium Poppy) they must have a licensed Line 17: Pharmacist employed at each location they plan to sell these drugs.

Line 18: ARTICLE VI: All Current laws, policies, and bills that conflict with this Line 19: Bill will now be deemed null and void.

Line 20: ARTICLE VII: This Bill shall be implemented exactly 16 days upon its Line 21: passage.

Be it enacted,

Line 01: ARTICLE I: The purpose of this bill is to create a State Juvenile Defender

Line 02: Department (SJDD), a state funded and managed agency responsible for

Line 03: employing and providing public defenders who exclusively represent

Line 04: juveniles in juvenile courts across all Virginia counties and cities. This

Line 05: department will ensure that every minor, regardless of financial status,

Line 06: has access to adequate legal representation in all juvenile proceedings.

Be it enacted,

BILL: Requirement for Jury Trials for Juveniles in Virginia

Section 1:

This Bill aims to mandate that juveniles aged 15 to 17 who are charged with a crime in the Commonwealth of Virginia be required to have a jury trial. This will ensure their right to a fair legal process and proper representation in the justice system.

Section 2:

In providing a structured approach to justice for juveniles, the Bill stipulates that all cases involving these individuals shall be dealt with in a court setting that includes a jury, thereby enhancing the accountability of the judicial process.

Section 3:

- (a) This Bill seeks to uphold the principles of juvenile justice, ensuring that young individuals are afforded the same rights to a jury trial as adults, thus reinforcing the integrity of the legal system.
- (b) The Judicial Advisory Board will review local court practices regarding juvenile cases, and a report will be submitted to the General Assembly annually to ensure compliance with this requirement and evaluate any necessary adjustments.

Section 4:

This Bill shall take effect on July 1, 2025, directing relevant judicial authorities to implement the necessary changes to ensure that all juvenile cases involving individuals aged 15 to 17 are processed with the inclusion of jury trials.

Requirement for Photographic Evidence in Speed Camera Violations

Be it enacted,

BILL: Requirement for Photographic Evidence in Speed Camera Violations

Section 1:

This Bill aims to enhance the accuracy and fairness of speed camera violations by mandating the inclusion of photographic evidence of the driver alongside the license plate in all related citations

Section 2:

All speed cameras utilized for traffic enforcement must be equipped with technology capable of capturing clear images of both the vehicle's license plate and the driver's face at the time of the violation. Citations issued for speed camera violations shall include this photographic evidence to ensure proper identification and accountability of the driver.

#### Section 3:

- (a) This bill seeks to protect the rights of drivers by ensuring that violations are substantiated with identifiable evidence, reducing the potential for wrongful citations.
- (b) A Compliance Assessment Board, consisting of experts in traffic law and civil rights, will monitor the implementation of this requirement and assess its impact on traffic enforcement. The Board will submit findings to Congress annually.

Section 4:

This bill will take effect on January 1, 2026, directing relevant transportation and law enforcement agencies to update their speed camera systems and practices following this legislation.
